## IMPRESSIONS GALLERY EXHIBIT PROCEDURES

**ELIGIBILITY:** Impressions Fine Art Gallery shall be open to all of the visual arts. Original art will be accepted. No reproductions.

**SUBMISSION DEADLINE:** The deadline has been updated, it is now June 4, 2025. All submission requirements are included on the Artist Submission Form. If an artist submission is incomplete at deadline, they will not be considered.

**REQUIREMENTS:** All art exhibited within the Impressions Gallery shall receive approval from the Jury Committee prior to the exhibit.

**SUBMISSION FEE:** \$25

**NOTIFICATION OF ACCEPTANCE:** The artist will be informed of acceptance via email on June 10, 2025. Delivery of accepted artwork will be June 13<sup>th</sup> and 14<sup>th</sup> from 10am-2pm.

**ART DELIVERY:** The artist can deliver their art to the Impressions Gallery June 13<sup>th</sup> or 14<sup>th</sup> from 10am-2pm.

**DURATION:** The duration of this Exhibit is June 20- September 1, 2025. We are testing the waters and if the concept is successful, we are very hopeful to continue the gallery as a permanent space within the Blue Harbor Resort.

**VOLUNTEERING:** Artists will be asked to volunteer in the gallery a minimum of one 5 hour shift per month. The Impressions Gallery would like to highlight the benefits of the artist's volunteer hours, they are: increased visibility, networking, and the opportunity to showcase their work in a curated environment. During the summer, Blue Harbor Resort welcomes approximately 1000 guests per week. Blue Harbor Resort will be marketing the Impressions Gallery heavily through social media and additional platforms

**PRESENTATION:** 2D Artwork must be appropriately framed, matted (if appropriate) and hung with wire at the upper third of the piece. Sawtooth hangers will not be accepted. No political or religious themed works are accepted at this time. We will not be accepting AI art or AI manipulated photography. Artwork cannot be removed from the premises unless sold to a patron. All artists will receive more details at time of acceptance.

**SALES:** The artist will set the pricing on any item for sale. The gallery reserves the right to suggest pricing guidelines if needed. The artist will be notified via email upon the sale and given the opportunity to present a new piece to the jury. The artist will be paid 65% commission on each piece sold. At the end of each month, we will prepare a monthly summary for payment and Blue Harbor will issue checks.

I hereby release Impressions Gallery and Blue Harbor, curators, and organizers from any responsibility for loss or damage while the work(s) are in possession during the gallery exhibition and in transit to and from Impressions Gallery.
3. Submitting your entry authorizes Impressions Gallery and Blue Harbor to publish your images for purposes of gallery publicity. All artist credits will be included. **\*\*Note – artist may be asked for higher resolution jpeg images suitable for publishing.**
4. Artists warrant originality and ownership of the artwork(s) and that the artworks will not infringe upon any copyright, right of publicity, moral right, or any proprietary or other right of any third party. The artist warrants that (s)he has not used any copyrighted or licensed material (text or visual) in the artworks or in the making of said artworks without express permission of the owners of those rights.
5. Artists will indemnify and hold harmless the Impressions Gallery and Blue Harbor and anyone deriving their interest from, through or under the Impressions Gallery and Blue Harbor, from and against any claim, suit, action, liability or expense (including reasonable counsel fees) arising out of any matter or claim which would result from presentation of the artist's work at the Impressions Gallery, Blue Harbor or through using images of the artwork for publicity /advertising purposes.

6. Artists will be asked to volunteer in the gallery a minimum of one 5 hour shift per month. The Impressions Gallery would like to highlight the benefits of the artist's volunteer hours, they are: increased visibility, networking, and the opportunity to showcase their work in a curated environment. During the summer, Blue Harbor Resort welcomes approximately 1000 guests per week. Blue Harbor Resort will be marketing the Impressions Gallery heavily through social media and additional platforms.
7. Each artist may also participate in showcasing their art by creating their art "live" in Blue Harbor Resort. There are beautiful, well-lit areas overlooking the lake, just outside the Impressions Gallery to create a "studio for the day." Artists are also welcome to paint plein air anywhere on the Blue Harbor grounds. Artists may schedule their "studio" dates with a team member of the Impressions Gallery.
